2018 USS Nimitz Association History

President Wood conducted the Business Meeting in accordance with the Association's By-laws, with discussion of Audit of the Association financials, old and new business and selection for the 2021 reunion site. Nominations were taken from the members for the 2021 reunion site. New Orleans (Marc Berlin), Saint Louis (Mark Baca and Austin, Tx (Dave Wood), and Saint Louis, Mo. was selected, Mark Baca will be the Reunion Coordinator.

The Association is also exploring opening the scholarship to students in certified trade school programs.

Members of the Association participated in an interview process to share their experiences on Nimitz with the U.S. Navy Memorial Organization.

Friday 14 September 2018: The Business/Voting meeting was held and all business was settled. Dale Jones came to the reunion and signed up as a New Life Member in the Association...
