Year 2007 started with finances in good order. Our Regular Bank Account with the Navy Federal Credit Union revealed a balance of \$14,194.52, and the Ship's Store with a balance of \$850.00. The dollar value of Ship's Store stock to be determined prior to bringing the store back on line and posted on the web site.

The Association continued to grow slowly in 2007; however, the large numbers of members that were not current in their dues on 1 January was quite large.

I applied for the astronaut program 8 times, more than any other officer except my friend and fellow P-3 pilot, Captain Mike Foreman. Mike made it into the astronaut corps in 1998. I was a finalist for selection in 1994, but never was selected for the program, Challenges abound! The challenge of not selecting almost crushed me, but I remembered VADM Tuttle's sage words. I looked for the great opportunity in the despairing defeat, and began to write about what I felt. Words led to paragraphs, then pages, and finally a novel. That novel, once edited through 3 years of extremely hard work, found its way to the bookstore after a fun bidding war between multiple publishers. Now, to my amazement, there are three books on the shelf that bear my name. All written about a Navy astronaut who works hard to get selected, then heads to Mars, but has to leave a wife and kids behind. He's stuck with that dilemma that most of us Navy folks face... to pursue marriage or mission. He chose mission, and life is not all rosy as a result.

Had I made astronaut. I might not have been a writer. But I believe that God needed me somewhere else. He needed me to walk that path of seeking astronaut selection so that I could one day write about it with passion, understanding, and technical accuracy. He used 40 years of 'wandering in the wilderness' to prepare me to do God's work as a novelist. Great opportunities... being a published novelist... were brilliantly disguised as unsolvable problems."

On 24 March 2009, Captain Paul O. Monger relieved RADM Michael C. Manazir (16 March 2007 - 24 August 2009), becoming the 15th Commanding Officer of the Great Ship NIMITZ (CVN-68). NOTE: Not wishing to refer to any of our Members as "old", but our Association Founder and Historian, Bill Paschall, completed 30 years of active naval service on 1 July 1980, about two years before Captain Monger graduated from the Naval Academy, and at this writing he is still with us at age 79.

Having been officially organized on 1 July 1997, our Association celebrated its 12th Birthday in 2009. Our first reunion was held 18-22 March 1998, at the Lake Wright Resort,

Norfolk, Virginia.

On 2 December 2010, NIMITZ changed homeport to Bremerton, Washington.

GREETINGS SHIPMATES

As we ended year 2010, our finances were in decent order; however, our Membership seems to be in melt down. We ended the year with 108 Regular Members and 36 Life Members for a total of 144 active members, however, our total of former and now inactive members total a disappointing 547. We need all Members in Good Standing to step up and become recruiters, bring back former members and sign up new members. An Association like ours should have a Membership in excess of 1000 as other carriers do. At our very first reunion at the Lake Wright Resort, Norfolk, Virginia in 1998 we had an attendance of 160, and as the word went out in the

Norfolk/Virginia Beach Area, by the time our reunion was over we had a total of 220 Members on board, compared to just 144 fourteen years later.

In spite of our low membership, our finances are in fairly good order. Our half & half drawings at reunions, silent auctions and small profits from the "Pour Your Own Bars" have kept pace with the annual \$2000 paid out to Scholarship Winners. As of January 1, 2010 our bank total at the Naval Federal Credit Union was \$12,063.95. A small profit was realized at the Scottsdale Reunion in October: Income: \$2749.00, Expenses: \$968.24, leaving a profit of \$1760.76. The payment of annual dues assists in keeping us solvent. As our Treasurer, John Wilder is doing a great job in managing our finances.

"Freedom has a flavor that the protected will never know."

"It is such an honor to speak in front of you. My Granddaddy [Bill Paschall] told me that you usually have retired Admirals speak at these reunions, so I am truly humbled and blessed. I want to...thank you all for the two Scholarships you awarded me... These scholarships paid for my books for three years and helped me move into my first apartment my freshman year of college. Not only do I thank you, but my father does as well! Like my grandfather said, after graduating I decided to join the military and serve as an officer. Coming from a Navy family I initially wanted to join the Navy. I went to basic training in Fort Jackson, SC and then two days later after graduation started Officer Candidate School...in wonderful Ft. Benning, commissioned a 2LT on 26 April 2007. My father read me the Oath of Office and I was fortunate enough to have my Grandfather there too. After OCS I went to the Officer Basic Course II in Fort Sill, OK. I then went on to the Signal Officer Basic Course where I was branched a Signal Officer. From there I received orders to the 11th Signal Brigade out of Fort Huachuca, AZ and deployed to Balad, Iraq in December 2007 with the 40th Signal Battalion. During my deployment I was the Network Infrastructure Officer in Charge on Joint Base Balad. We had the most advanced strategic network ever in the history of war. I like to tell everyone we were like the "Bell South or Comcast" of Iraq. We provided unclassified and classified phones and internet to the largest logistics base in Iraq. We had an attack almost every day...some days were worse than others and we had some close calls with buildings we were working in getting hit. I was blessed to bring every one of my soldiers home though. I returned home from Iraq in March 2009. The tactical signal equipment the army has now enables us to deploy anywhere in the world and provide phone and internet services to the war fighter. Unlike my mission in Iraq, my soldiers now had transportable satellite systems that ran off of generator power. I decided to leave Active Duty Army in early 2010 and try my luck as a civilian. I signed to be an army reservist and to my surprise it is a lot more work than I ever thought. I am now the Headquarters and Headquarters Company Commander in a Signal Battalion here in Mesa. I love being a company commander and to be able to do what I do best... lead Soldiers. I will be on full time orders all of 2011 as the Officer in Charge of our Battalion equipment fielding. For me, the military gives us a sense of pride. General MacArthur said it best in three words during his speech to West Point Graduates in 1962: "Duty, Honor, Country." Those three hallowed words reverently dictate what you ought to be, what you can be, what you will be. They are your rallying points: to build courage when courage seems to fail; to regain faith when there seems to be little cause for faith; to create hope when hope becomes forlorn." The military also gives us camaraderie and a bond of undergoing hardships, pain, and without. There's a saying that says, "For those who fight to protect it, freedom has a flavor that the protected will never know." It is up to us, as veterans and service members to remind Americans of the freedoms they have. To remind them not to take what they have for granted and to appreciate the life, liberty and justice given to them at birth. It is up to us to remain humbled yet proud, a role model but not a celebrity, disciplined and committed to standing up for what is right and what we have fought for. I salute you all and all the veterans who have fought to protect our freedoms and the many men, women and close friends of mine that are fighting in Iraq and Afghanistan now. Limits the Spouse Advocate to two consecutive terms but allows election to additional terms if there is a 2- year break after the second consecutive term.

If the President of the Association is unable to attend a reunion, meetings of the Association shall be presided over by the person in the following order: Vice-President, Secretary/Treasurer, 1st Immediate Past President and 2nd Immediate Past President.

A person may be nominated for an officer position from the floor if there are no persons who have filed prior to the reunion meeting.

Board of Directors

More clearly defined the Webmaster's duties.

Eliminated some duties of the Veteran's Service Officer that were not applicable or beyond the scope of the organization.

Added a Former Commanding Officers Liaison position as a voting member of the Board of Directors to keep in contact with all former Nimitz skippers.

Meetings - Allows emergency meetings to be held via telephone conference and voting on emergency matters via U.S. Mail or email may be authorized by the President of the Association due to the distributed make-up of the Board. After an email or postal mail vote is taken, the President shall make the results known to all Board members.

Life Membership - Life Membership may be awarded to anyone in any membership category from time to time by vote of the membership at a reunion for exceptional service to the association. Life Members so awarded have full voting privileges.

Scholarship

Raised the amount of the FADM Nimitz Scholarship to \$3,000 per award.

Allowed the board of directors to authorize additional scholarships, when funding permits.

Added Community Colleges and Associate's degrees to those studies eligible for the scholarship.

Changed the scoring criteria, work rules, and specific naming of extracurricular activities in the selection criteria for the scholarship.

Added eligibility for the scholarship to active (dues-paying and in good standing) members of the association.

President Ed Deats announced openings on the Staff to be filled for the coming year: Secretary/Treasurer, Spouses Advocate, and Historian. Members volunteered for the following positions: Audit Committee: Scott Patterson. Nominating Committee: Ray Bigelow. Historian: Myrl Wallace. No volunteer came forward for Secretary/Treasuer, John Wilder volunteer, who was term limited, agreed to serve three more months and was so approved by a vote of the Members. The position of Skipper's Liason was filled by RADM Jack Batzler

Thursday, 27 October was a Free Day for local touring and other adventures. One group rented two vans and took a trip to the Hard Rock Casino and Hotel in Biloxi. Others toured

the base, Fort Barrancus (which includes a National Cemetery), Pensacola Beach (a couple of sun burns), Seville Quarter, National Naval Air Museum, and likely local "watering holes" etc.

Friday, 28 October October was a busy day. At 0900, large group toured the Pensacola Historic Village, and afterwards, All Hands assembled at 1200 at the Pensacola Veterans/Wall South Memorial Park. Our banquet was held on Saturday 17 October, we did not have a special guest speaker this year. However, the banquet went over extremely well with 32 people attending. A DVD from current Commanding Officer Captain Ring was shown. Closing remarks included the mentioning of the 2016 Reunion being hosted by Waldo and Bea Brunner in San Diego, California.
